1. GP Referral Exercise Scheme

GM welcomed Steve Fenney, who leads the GP Exercise Referral Scheme at Saltash Leisure Centre. The scheme offers physical activity to improve health and well-being and patients with conditions qualifying for referral include high blood pressure, diabetes, overweight, asthma, circulatory/respiratory diseases, arthritis, depression and anxiety

There is no cost to the practice as the scheme is funded by the National Lottery and Sports England. A high number (approximately 75%) of referred patients go on to join the scheme resulting in inactive and often overweight patients committing to sustainable, healthier lifestyles, with more exercise and better attention to nutrition. The scheme offers discounted leisure centre membership for up to 2 years, after which the patient can choose to become a full-paying member.

The practice currently makes referrals but there is capacity for considerably more. The group discussed how the scheme could be promoted with minimal input by the practice.

The practice system search function could be asked to identify patients by criteria (medical condition) and notify them direct, with a short message or email. The emessage could be along the lines of: "You have been identified as one of our patients whose health would most benefit from the GP Exercise Referral Scheme that we are operating with Saltash Leisure Centre. The scheme is sponsored by the lottery and entitles you to much reduced membership. For further details and to register your interest, please contact ... "

SF said there may also be a possibility for patients to self-refer.

The success of the scheme would be monitored by the Leisure Centre - number of referrals received, how many patients take up their referrals, patient attendance and compliance, improvement in patient symptoms etc. This should produce some meaningful data.

The following actions were agreed:

Explore the self-referral option and talk to AT re how to communicate the message

AT to invite SF to meet doctors and clarify referring criteria

A supply of green Healthwise explanatory leaflets in waiting room and notice boards around Saltash.

Still looking for a replacement for 6 session partner GP and trying to recruit a locum for maternity cover from end of May, for 6 session salaried GP about to go on maternity leave.

Social/Fundraising

Dress down Friday raised funds for a student volunteer trip to Senegal Soup kitchen volunteers on 1st May Coronation lunch for staff 5/5/23

Complaints/compliments

No significant complaints outstanding - General theme of patients complaints not receiving what they think they need or as soon as they would like.

Compliments - feedback from patients that practice is friendly, helpful and organised.

South West Hydration Project

NHS England - Circulating a leaflet and survey to men over 70 in the community about hydration, the working aim of the project is to look at whether older men's daily intake of fluids is sufficient and to work with them to create practical and sustainable ideas that would support them to drink more fluids with the aim of reducing the risk of Klebsiella Blood stream infections in men 70+ who live in their own homes. AT will keep the group updated.

GM suggested, and the group agreed, that a contribution from the £600 remaining from previous fund-raising activities could be made in order to promote the work of the PPG in the Saltash Observer.
